and onto the smallbore-only rifle range behind those ranges. During the closure of those ranges, daily members will be diverted to the 25/50yard pistol range. This project is expected to take a minimum of 30 days to complete. Other ranges will be scheduled for mining, but I have been assured that it will not impact any major matches. This is an ongoing process, and from time to time each of us will be inconvenienced by a range closure, but that is one price we must pay for the freedom we enjoy.

Along the line of freedom, I have been asked the club's stance on backing political candidates. The answer is this, Gateway Rifle and Pistol Club does not endorse any candidate running for office. However, Gateway Rifle & Pistol Club welcomes the views of all political candidates. The following candidates have taken time out of their busy schedules to come to our club to express their views on 2<sup>nd</sup> amendment rights: Jennifer Carrol, David Gooding, and John Rutherford. We are a strong political force of over 2500 individual voters who can be expected to vote to maintain their 2<sup>nd</sup> amendment freedoms. The spouses and friends of those 2500 members can easily represent an additional 2500 to 10,000 votes. Jodie Graves as President of GRPC can not endorse a candidate. However, Doctor Jodie Graves, shooting enthusiast, will cast her vote for those candidates that support her views toward maintaining our constitutional rights and victims rights. The best way to ensure that your beliefs and freedoms are maintained is to support those candidates who represent your

views. The NRA will gladly provide you with the names of the candidates supporting our position as gun owners.

We would like to welcome Larry Gwaltney as a new member of the board of directors and Bruce Wells as the new Public Relations officer. Since these two individuals routinely came to board meetings and have shown a genuine interest in the direction of GRPC, the Board of Directors

appointed them. The decisions made by the BOD are often difficult, but we are fortunate that every board member honestly seeks the greater good of the club. The individuality of each member balances many decisions. I have learned to appreciate the views of each member of the board and draw from their experiences.

I would like to address a criticism concerning BOD unwillingness to hear issues from the members during the monthly meetings. The BOD have the responsibility for setting club policy and maintaining club business. The meet-

ing begins at 7PM and should end around 9PM. This mandatory two hours is packed full of club business: financial report, managers report, safety concerns, policy review/implementation, match reports, committee reports, etc. We have 19 individuals representing 2300-2500 members. However, there are ways for club members to express their views at a BOD meeting. First, prior to the board meeting, you can ask the president to place you on the agenda. Second, you can write a letter to the board and the secretary will present it as correspondence to the board. You can not however, speak from the gallery during a meeting unless addressed specifically by the board to answer an enquiry. Since members feel they are being overlooked, I will permit members of the gallery to speak to the BOD at the conclusion of the meeting. These ground rules ensure fairness for everyone. 1. Make arrangements prior to the meeting. 2. Speak for a maximum of three minutes. 3. Present only facts: time, place, witnesses, safety issue, specific question. I may not be able to get to everyone who desires to speak. I must end the meeting no later than 9:10PM unless the BOD desires to discuss an issue more.

I want to thank all of you for permitting me to serve as president. I hope you will vote for me again in September.

PS Women's Field Day is rapidly approaching again. Let us make it even better this year.

heard around the club and maybe clear up a few misconceptions about the sport.

***“There’s no 180-degree rule, so IDPA is unsafe.”*** Well ...there’s no 180-degree rule when you’re getting mugged on the street either! IDPA’s purpose is to simulate realistic self-defense scenarios, therefore, muzzle control points in IDPA are dictated by individual club rules and range design. Some range bay designs can safely accommodate arcs of fire beyond 180 degrees, so mandating a 180-degree rule for all courses of fire in IDPA is unnecessary.

***“I get penalized for doing speed-reloads or not shooting from behind cover.”*** Speed reloads are strictly a game tactic. Discarding a partially loaded magazine or not getting behind cover during a real gunfight would be foolish, and IDPA is about *survival tactics*, not game tactics. In the real world, you won’t know in advance how long the gunfight is going to last nor how much ammo you will need.

***“There are too many rules limiting the type of equipment you can use in IDPA.”*** There are two reasons for this...the first is to make IDPA courses realistic. The second reason is so that IDPA competitions maintain a level playing field where you can compete with your normal carry gun and equipment.

***“IDPA courses of fire aren’t very realistic.”*** IDPA at Gateway is still in its infancy and we’re beginning to accumulate a variety of match props. IDPA is, after all, still a game, but we try to make it as realistic as well as competitive. Please join us and see for yourself.

## About the International Defensive Pistol Association

IDPA was founded by the same people who founded the International Practical Shooting Confederation (IPSC). IPSC started out as a defensive shooting oriented sport, but has evolved and changed. That’s not to say that there’s anything wrong with IPSC...the top shooters in the sport are phenomenal marksmen and athletes, and IPSC-style shooting is an absolute blast. But it isn’t exactly practical anymore.

Consequently, the original founders of IPSC formed the International Defensive Pistol Association, a new shooting discipline designed to test an individual’s shooting skills and survival tactics while solving realistic self-defense scenarios in a competitive environment. Since the sport is relatively new to GRPC, I’d like to expound on a few comments I’ve

- 1) .22LR rifles, in three classes: TI: Target Iron sighted, TS: Target Scoped, F: Free class- any safe .22LR rifle, which can use any sighting system and any type of front rest, but no rear rest.
- 2) All shooting is "belly," or prone.
- 3) All shooting is at 100 yards. No wind flags/etc beyond the muzzle of the rifle.
- 4) All shooting done on one piece of paper, which has the sighter and record bulls for simulated 800, 900 and 1000yd targets.
- 5) Timed match, approx. one hour per match, if anyone ever wants to go for the three match aggregate, OK.
- 6) Each "distance" is scored as a match, and the aggregate is a separate winner.
