# 2009 ANNUAL MEETING, SWAP MEET, ELECTIONS, PROPOSED BYLAW CHANGES and POSSIBLE LAND PURCHASE

#### SATURDAY, NOVEMBER 7<sup>TH</sup> 2009 SCHEDULE OF EVENTS

07: 00 AM Gates open to set up for swap meet

08: 00 AM Swap meet continues and ranges are open for firing

10: 00 AM Club Annual meeting begins, reports, vote on bylaw changes, vote on possible land purchase, then cast election ballots

12: 00 PM Lunch is served while votes are being counted

In addition to annual reports, a vote on bylaw changes and our election process, a very important issue will be presented to the general membership. That issue is the possible purchase of addition land for our Club. The Board of Directors appointed a Land Acquisition Committee (LAC), Lloyd Watkins, Sam Grimes, Bill Craig and Ron Barr, to look for land to purchase as part of a long range plan to insure the continuance of Gateway Rifle & Pistol Club (GRPC) for the foreseeable future and beyond. We have no intention of moving from our present location unless forced to do so. Initially, the search for property was kept on a low key basis to keep from compromising our bargaining position. Unfortunately, many rumors began to spread prompted by an article in the Baker County Newspaper which reported that a GRPC range in Baker County was a "done deal." The newspaper reported incorrect information. The Board of Directors has not signed any contract to purchase any real estate anywhere. The LAC has spent hundreds of hours making land searches, making trips, examining land, consulting environmental experts, seeking legal advice and contacting banks. The results of all these efforts have been reported to the Board of Directors and discussed in detail. Any purchase or change this large is up for approval by the general membership which is on the agenda of our annual meeting.

- 1. The proposed property acquisition is part of a long range plan to provide "safe haven" for GRPC in the event we are curtailed by law or court action to cease part or all of our activities at our present location. If we wait until the "unthinkable" happens, without an alternative, we will be out of business as a Club. We also will have the land as an investment as land prices are down at this time and interest rates are low.
- **2.** Primary considerations are that:
- **a.** We must have a location that has miles of safe "un-saleable" property for a safety zone to our north which is our direction of shooting.
  - **b.** We must have room enough to expand on that property.
  - **c.** We must have compatible neighbors.
- **d.** We must have a location that is friendly to our needs in the way of zoning.
- **e.** The location should be less than an hour's drive from our present location of GRPC or from Jacksonville (intersection of I-10 and I-95.
- **f.** Cost should not exceed \$1.3 million. All of the above is governed by the cost of land, our money on hand, our projected income and availability of suitable locations.
- **3.** At this point, we have a tract of 201.2 acres that seems to meet our requirements. The details of this property will be presented and a vote to proceed in the purchase will be conducted at the annual meeting. Even after that vote, and the contract is signed, if the safeguards of "due diligence" regarding zoning exemptions in our contract cannot be met by Baker County or the environmental survey shows the land is unsuitable for our purposes, the contract will be null and void.

In summation, our priorities are; huge safety zone to the north, useable property in a rural location, good access within reasonable driving time from Jacksonville with a property size of 100 acres or more for less than \$1,300,000.

### DRAFT COPY of the PROPOSED CHANGES in CLUB BYLAWS as APPROVED by the BYLAW COMMITTEE and BOARD OF DIRECTORS

These changes will be submitted to the membership for approval in the November 2009 general meeting. However, they must be sent out to all members by US mail (The Muzzleblast) at least 15 days prior to the meeting and approved by a two thirds majority that that meeting.

- 1. New wording or changes are in **bold Italics**.
- 2. Items or words to be removed have strikethroughs like this: To be or not to be.
- 3. Paragraph 10 is deleted because its meaning is not understandable.
- 3. Paragraph 11. (c) (5) was moved to paragraph 2. (e) and simplified.
- 4. Access to our present Bylaws is available on our Internet Web Site to 2009 Club members that are verified by our Web Master. A copy is also available for 2009 members to be read at our Club Office.

#### By-Laws of Gateway Rifle & Pistol Club, Inc.

#### 2. Membership

(e) Each new annual member shall receive a copy of the Club Handbook.

(b) The regular business meeting of the corporation for the transaction of ordinary business shall be held on the second Monday of each month at such a time and place as may be affixed by BOD. The meetings will be conducted with parliamentary procedures as found in the published book, Robert's Rules of Order.

### 6. Duties of Officers

(c) Secretary. The Secretary shall conduct official correspondence—pertaining to the proper preparation and forwarding of all reports. He shall notify the members of the Board of Directors of all meetings as required by these by laws. He shall keep a true record of all meetings of the Board of Directors and of the meetings of the membership of the corporation and shall be the official custodian of the books and papers of the corporation, except the Treasurer's books of the account. An up to date copy of the BOD and General Membership minutes will be kept in the Club Office for review by all members. He shall also keep a master copy of all old, new and revised policies. The Secretary shall be responsible for reaffiliating this corporation annually with the National Rifle Association. (c) Secretary: Shall conduct official Club Correspondence. Shall keep a true record of all meetings of the BOD and of the Membership and shall be the official custodian of all (except treasurer's financial records) Club records and papers. An up-to-date copy of the BOD and General Membership minutes will be kept in the Club office for review by all Club Members. Shall also keep a master copy of all old, new and revised policies. Shall be responsible for reaffiliating the Club annually with the National Rifle Association, Inc. Shall maintain accurate corporate relationship with the state of Florida.

#### 7. Board of Directors

- (a) The BOD shall have general supervision and control of all the activities of the corporation. Specifically, the BOD will be in charge of club policy and approval of expenditures.
- (d) At any annual meeting of the membership of this corporation or at any special meeting of the membership, persons in addition to the officers of the corporation may be elected to the membership on the BOD. The number of directors will never be less than five (5) nor more than nine (9).

#### 10. Waiver of Notice

Whenever, under the provisions of any law or under the provisions of the Certificate of Incorporation or By laws of this corporation, the corporation or the Board of Directors or any committee thereof is authorized to take any action after notice to the members of the corporation or after the lapse of a prescribed period of time, such action may be taken without notice and without the lapse of any period, if at any time before or after such action is completed, such requirements be waived in writing by the person or persons entitled to said notice or entitled to participate in the action to be taken.

#### 11. Range Rules and Regulations

(5) Each new member at the completion of the orientation and safety video and test shall receive a current copy of the range rules, membership handbook and by

#### ABSENTEE BALLOTS?

We do not have an absentee ballot this year. We had no absentee ballot until the last few years when there were more people running for office that there were positions open. The Board of Directors (BOD) set up a uniform policy guide for an absentee ballot for such occasions. There is no requirement in our bylaws or Articles of Incorporation which require an absentee ballot.

Until the Board meeting on 12 October, (27 days before the annual election), no one had contacted me, in any way, shape or form, to state that he or she were interested in running for any position on the BOD. Board policy says absentee ballots, if done, require 45 days notice in advance of the annual meeting. That deadline could not be met with only an empty absentee ballot.

Several people that Lloyd Watkins and I asked in the last three months to run for office declined. I was not surprised. In these past years as President and Secretary, I have repeatedly asked in the Muzzleblast for people to step forward to serve on the BOD. The previous issue of the Muzzleblast asked for people to send in an article for publication. Finally, one person, Toby Nolan did so for this edition. We need people who have time to volunteer to work on projects and committees. Just attending BOD meetings to cast a vote or volunteer their advice is not enough. We need officers and Directors who have the time, interest and inclination to work in the jobs. Very few came forward in years past. We generally just reelected the same group of people year after year who did their best to do what they thought as best for GRPC.

This past year, in 2008, due to proposed major changes in our Club's operation that a portion of the BOD at that time wished to implement, there was a members' "revolution." Twelve of the fourteen open positions were filled by newly elected BOD members. Only Jody Graves and I retained our previously elected positions. This year's BOD has done a lot of work. Much more needs to be done. Eight newly elected BOD members for 2009 now have a year's experience in helping to manage the Club's operation. The ninth BOD member moved from Jacksonville.

I recommend that the present slate of officers and three BOD members up for election be reelected. A fourth Director's position is open on the BOD. Toby Nolan was one of the few Club members who took the time and interest to attend many BOD meetings. He is running for office. Therefore, I recommend him as well. As of this writing, 19 Oct, 2009 no one else has indicated their interest in running for office.
